B.Cr All Directors who are not subject to appointment by Daveloper shall be elected by majority vote of those members other than Developer present at a meeting at which a quorum of members is present.

C.Dr All Directors, whether appointed or elected, shall serve for a term of two (2) terms of one (1) years in accordance with the provisions of the Bylaws. Any elected Director may be removed from office with or without cause by majority vote of the members other than Developer, but not otherwise. 
