THIS FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR BROAD POINTE SUBDIVISION ("First Amendment") is made and executed to be effective this 25 day of 100, 2021, by the Broad Pointe Owners' Association, Inc. ("Association").

WHEREAS, the Declaration of Covenants, Conditions and Restrictions for Broad Pointe Subdivision and By-Laws dated March 10, 1999 were recorded on March 17, 2000, in Book 1270 at Page 2274 in the Office of the Register of Deeds for Beaufort County, South Carolina ("Declaration"), and the Quitclaim Assignment of Declarant's Rights to the Association dated November 11, 2005 was recorded on November 22, 2005, in Book 2273 at Page 0276 in the Office of the Register of Deeds for Beaufort County, South Carolina; and

WHEREAS, pursuant to Article X, Section 5 of the Declaration, the Declaration may be amended by affirmative votes of at least two-thirds (2/3) or 66.67% of the total votes eligible to be cast by all Members; and

WHEREAS, on December 5, 2019, a meeting was held with 43 members casting votes in person or by proxy. Of the 43 total votes cast at the meeting, 38 affirmative votes were cast, approving the following amendments:

NOW, THEREFORE, the Association hereby amends Article IX, Section 11 of the Declaration as follows:

The recitals set forth above are incorporated herein by reference.

Article IX. USE RESTRICTIONS FOR THE PROPERTY. Section 11. Motor Vehicles and Trailers.

11-A. Broad Pointe residents are permitted to ride their properly licensed motorcycles between their garages and the Broad Pointe gate, via the most direct path between the two locations. Owners will operate their motorcycles within Broad Pointe only between the hours of 9:00 AM and 9:00 PM, and only in transit between their residence and the main gate.

No other non-resident motorcycle riders will be allowed to ride motorcycles within Broad Pointe.

## Ratification of Declaration and By-Laws.

Except as modified or changes herein, the Declaration and By-Laws are hereby ratified as if restated fully herein.
