The purpose of the Architectural Review Board is to implement covenants and carry forth responsibility of design review set forth in the restrictive covenants of Fripp Island. The FIPOA Board of Directors appoints the ARB members.

ARB meetings are held the first and third Thursday of each month at 8:30AM in the FIPOA Boardroom. Submittals must be received in the FIPOA office by 4:30PM the Wednesday, a week prior to the meeting. If not received by 4:30PM it may be deferred to the next meeting of the Board. VEHICLE DECALS: Owner decals allow your family's vehicles to enter the Security gate without stopping for a pass. Please contact the FIPOA Administration office to get your decals. You can fill out the forms online at www.frippislandliving.com and the decals will be mailed to you, or you can come to the office at 225 Tarpon Boulevard. Every parcel is entitled to 5 vehicle decals free of charge. Additional decals are \$50 per year (2 year decal). Replacement decals are \$5.00 each.

GOLF CART REGISTRATION: Call FIPOA Security (843) 838-2334 to schedule an appointment to register your golf cart. Golf carts that are not registered cannot be operated on the roadways of Fripp Island and are subject to being stopped. Golf carts being operated on the POA roadways must be insured and have, a rearview mirror, headlights, taillights and brake lights. Golf carts being operated on the roadways could be issued a POA summons for operating an unlicensed motorized vehicle, which carries a fine.

Golf carts brought to the island by non-owners must pay a registration fee within 24 hours of arrival (Subject to fine for not registering). ATV's are not allowed. (Subject to fines and impound fee).

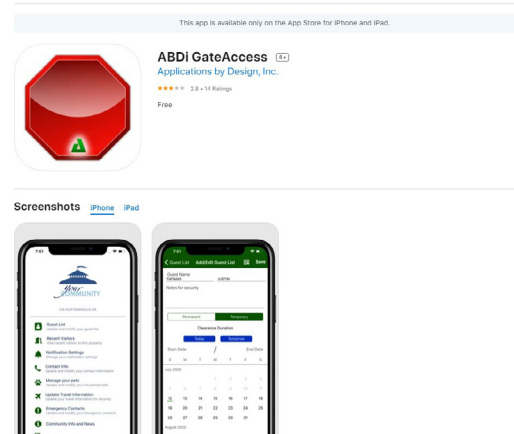
INFORMATION

AREAS OF RESPONSIBILITY: Security, Architectural Review Board for Single Family Properties, Roads, Bridges (except the inlet bridge), Drainage, Bike Paths, Beach Accesses, Davis Love Park and Hannah's Park and Common Grounds issues.

SECURITY is maintained by the Fripp Island Property Owners Association on a 24-hour basis. The Security officers make routine patrols throughout the island. Please call them if you should have a problem (843) 838-2334. In an emergency please call 911.

GUEST PROCEDURES: When you purchased property, you were given a PIN number. You can arrange a guest pass for your visitors through several ways:

- Or you can use ABDI Gate Access through the web or App that is available on the app store Google Play. Gate access can be download your mobile device (This includes Ipad, Chromebook, etc..).

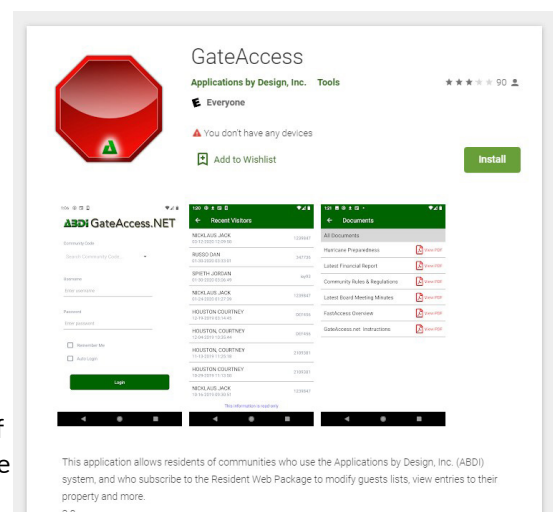

VEHICLE DECALS/ARB PERMITS

Decals allow access onto the Island without stopping at the Security Gate. Each owner is entitled to 5 decals free of charge. All vehicle decals after five are \$50.00 per year. All replacement decals are \$5.00 each.

GUEST & VEHICLE PASSES

Contact Security for guest passes or go to the weblink to enter your own (www.gateaccess.net). To register your golf cart, you must bring your cart to Security along with proof of insurance.

FRIPP ISLAND ARB'S FREQUENTLY ASKED QUESTIONS

Q: Do I need ARB approval to repaint or re-roof my house the same color/material as it is now?

A: No, but you still need to complete and application and post a permit; There is no cost.

Q: When must an application be turned in to be reviewed at the next ARB meeting?

A: Applications must be received in the ARB office by 4:30 PM the Friday prior to the meeting. If not received by 4:30 PM, it may be deferred to the next meeting of the ARB.

Q: Do I need approval to remove a dead tree?

A: Yes, there is a tree removal application that needs to be completed and turned in for the ARB meeting. Mark the tree with tape for easy identification and your ARB representative will inspect the tree. It is also a good idea to submit a letter from an Arborist that states the tree is not salvageable.

Please note: If the tree trunk is within 10 feet of the roof line of the house or garage, ARB approval is not needed. When removing any tree please contact Beaufort County's Zoning Department at (843) 255-2170 to inquire about required permits.

Q: Do I need ARB approval to resurface my driveway?

A: If you currently have a concrete or non-pervious driveway, the ARB will have to review your submittal for resurfacing. If you are replacing a pervious drive to match the existing driveway a permit can be issued as soon as an application is received. If you want to change the material or color of the driveway, the ARB must review your submission at its regularly scheduled meeting. Please submit a sample material for the approval process.

- The use of pervious surfaces should be the first course to consider when designing or replacing driveways. If desired, concrete garage floors and entrance pads are acceptable.
- Acceptable pervious materials are: gravel grids, pervious concrete, pavers, bricks and crushed gravel. All offer improved drainage and water runoff versus concrete.
- Concrete driveways are still acceptable but it depends on the water runoff. A current concrete driveway does not automatically guarantee a concrete replacement.
- If pervious material is used instead of concrete an anchored border is required.

Q: How much time do I have from the approval date to start and finish a project?

A: Conceptual approval for a project is good for 12 months. Once a permit is issued the clock for project completion starts ticking. New home construction MUST be complete within 15 months of permit date; all other projects have 9 months to be complete. Unless you complete a permit extension request, a fine will be assessed on a daily basis for any project that goes on beyond the allotted time frame.

Q: If the conceptual approval expires, do I have to re-apply and go through the review process again?

A: Yes

Q: If I want to demolish an existing home to make room for new construction, will I need a permit?

A: A demolition permit is required before you can demolish an existing structure. A permit fee of \$100 must be submitted along with a copy of a Beaufort County demolition permit and a current tree and topo survey.

Q: What is the minimum square footage I can build?

A: Each subdivision has its own requirements that are laid out in the Covenants.

Q: Does the ARB have height restrictions?

A: Yes, no building may exceed 36 feet in height from the average existing grade and final grade to the peak of the roof, except a 4' maximum variance may be granted by the ARB if an approved sprinkler system is installed.

Q: Are setbacks for new homes and additions measured to the exterior wall or the roof overhang?

A: Setbacks are measured to the exterior wall.

Q: Do I need a permit to repair or replace material on the exterior of my home?

A: Yes, you will need a permit for any exterior maintenance and repairs. A permit can be issued without ARB review as long as the repairs do not change the look of the property. If a change to the exterior is being made, ARB review will be needed before a permit can be issued.

Q: What do I need to do if I want to change the color of my home?

A: Complete the Exterior Alteration/Improvement Application and submit a paint sample. Samples are to be a minimum of 8 1/2"x11" or you can paint a section on your home. A permit fee of \$50 must be submitted with the application for new paint color approval.

OTHER FIPOA FREQUENTLY ASKED QUESTIONS

Q: When are the POA vehicle decals renewed?

A: The current vehicle decals are valid October 2022 thru Fall of 2024

Q: How do I apply for POA vehicle decals as a new homeowner?

A: Once you close on your new property you can visit the POA office in person, online, or email us and we will be happy to assist you. Each property is allowed (5) free vehicle decals.

Q: When are the annual Homeowner Assessments due?

A: The annual assessments are billed in November and are due January 1st of each year.

Q: Is there a list of preferred contractors on the island?

A: You can visit our website frippislandliving.com for is list of approved contractors under owners resources on the website. *These contractors are not endorsed by FIPOA, but rather they have requested to be on our list for homeowners.*

Q: Do I pull out the trash to the curb on trash days?

A: No. We have backdoor service. The trash recepticals have to be in the enclosed area at all times.

Concrete trucks are charged \$25 per trip. Commercial Vehicle decals are issued in April each year. Purchase in January will prorate the cost to ½ price. Purchase of an annual commercial decal entitles the service provider to be listed on the Service Provider list on the POA website.

Access fees for employee vehicles and commercial vehicles for the purpose of providing products and services exclusively for the owners, from time to time, of the Marina area, the Springtide area, the Beach Club area, the Ocean Point area and the Ocean Creek area (the "Resort Properties") are waived as being included in the commercial assessment for each Resort Property in accordance with the 1983 Agreement and other agreements, which have been negotiated with the Fripp Island Property Owners Association. This includes commercial vehicles and vehicles of employees exclusively working for the owners of the Resort Properties and employees exclusively working for businesses operating under contractual arrangements with the owners of the Resort Properties. The names of commercial vehicles and these employees appear on a list provided to the FIPOA by the owners of the Resort Properties and shall be added to from time to time.

No person entering Fripp Island in a vehicle with a business, commercial or contractor decal shall be allowed to engage in any activity on Fripp Island other than business, commercial or construction. A violation of this prohibition will result in the revocation of such privileges for that person or business entity, or both.

DELIVERIES

Beware of vendors who promise free delivery of goods! They must still pay Fripp access fees and may try to pass that fee on to you. Discuss this at the time of purchase.

If a contractor comes to the gate unprepared to pay the access fee, they will not be turned away—if we are able to contact the property owner and get assurance that the owner will pay the fee in a reasonable time. (Within 14 Days of Delivery).

If you have an emergency, please call Security to ensure gate access.

Contractors can only work on the weekend if permission has been given by Security.

Contractors must also be put on a weekend worklist after permission is given, and quiet work is only allowed. If you have questions, please call Security at 843.838.2334.

PARKING

Handicap Access is available at Beach Access 15 on Rock Beauty Road. There is dedicated handicapped parking and a level sand path. Visitors need to go to the security office at 225 Tarpon Blvd. to register for a handicap sticker to park at Rock Beauty. Please be aware of the parking signs that designate whether it is Golf Carts only, or Golf Cart and Regular Vehicle Parking.

THE NATURE OF FRIPP

As distinct as every personality on Fripp Island may be, we all have one thing in common: we respect and celebrate the island's nature/wildlife. We strive to live in balance with our South Carolina environment and protecting its beauty.

Every home on the island is surrounded by scenic views and lush, natural landscapes. Marshes, beaches, golf courses, maritime forest, open spaces, and homes are hidden off-the-beaten-path.

As homeowners, you will quickly get to know all the island's wildlife; nature is just outside your door. Deer, raccoons, alligators, loggerhead sea turtles, and flocks of birds are among your neighbors.

A morning bike ride, swim, golf or tennis game, or walk along Fripp's many paths and trails keep you in constant contact with the abundant wildlife and spectacular Lowcountry landscape that surrounds you. Take a moment over the next few pages to read and discover about our conservation efforts, the do's and don'ts with wildlife and our habitats, and most importantly, how you can continue to embrace the environment as a precious and unique resource.



In 2013, the National Wildlife Federation (NWF) certified Fripp Island as a Community Wildlife Habitat after months of work of a prior task force on the island. This is a coveted, nationally-recognized honor; at that time, there were just three exclusive certified SC communities: Kiawah, Callawassie, and Briarcliff Acres. Fripp Island was fourth in the state of South Carolina to be named. Today we find six Certified Community Wildlife Habitats in SC and 135 across the nation.

Will You Join Us and Register Your Property With The National Wildlife Federation?

It is super simple, takes less than 5 minutes online, and requires a \$20.00 donation to the NWF. They used to call this program Backyard Habitat, but now that has evolved into the Garden for Wildlife. But no need to have a yard or a garden; a condo balcony will work just as well. Visit <https://www.nwf.org/garden> to register.

As we raise Fripp's profile as a Wildlife Focused & Friendly Community, we believe everyone benefits as we attract visitors and future owners who are eco-friendly. Folks who would like to go birding as they golf; folks who tend to walk lightly on the land and be gentler with our wildlife.

There is a certificate of recognition and a one-year subscription to their excellent magazine, discounts at their store, and an opportunity to purchase a sign to display in your yard.

WILDLIFE

SEA TURTLES

Dozens of giant loggerhead turtles come ashore on Fripp each spring and summer to lay eggs. The Fripp Island Loggerhead Patrol, a large group of volunteers under the auspices of the South Carolina Department of Natural Resources, educates the public and protects the turtles. Mama loggerheads weigh between 250 and 350 pounds and return to the beach's vicinity, where they were hatched to lay their eggs. The hatchlings are just a few inches long and are drawn to the sea by the celestial light but can be disoriented by artificial light. Beaufort County's lighting ordinance requires no light be visible from barrier island beaches, thus the Loggerhead Patrol's reminder, "lights off on the beach."

Fripp Island Loggerhead Patrol

A dedicated team of trained volunteers goes out early each morning during the season (mid-May to mid-August) when loggerhead females may be laying eggs to locate and mark nests, and be sure that they are safely above the high tide. The incubation period for the eggs is between 45 and 70 days. Hatchlings emerge from the nest at night and are drawn to the sea by celestial lights. Volunteers can be identified by their turquoise Fripp Turtle Patrol shirts.

LIGHTS OUT! MAY-OCTOBER 10:00PM-6:00AM

Sea Turtles need a clear dark path beyond the high tide line at night.

When leaving the beach at the end of the day, visitors are asked to knock down the sand castles you built, fill in the holes you dug, take your trash off the beach and remove tents and chairs.

When you go for your nightly beach walk please leave the flashlights off, and if you should happen upon a sea turtle do not approach as this will disrupt her egg laying process. When the nest hatches, the hatchlings are just a few inches long and are drawn to the sea by celestial light, but can be disoriented by artificial light. Beaufort County's lighting ordinance requires no light be visible from barrier island beaches, thus the Loggerhead Patrol's reminder, "lights off on the beach." **Violations subject to \$100 fine and property confiscation.**



DOLPHINS

Fripp Island is surrounded by and contains diverse and interesting wildlife, one the largest and most intelligent of these creatures is the bottlenose dolphin. In the waters around Fripp, there are two primary populations that are here year-round: a harbor population and marsh population. Though bottlenose dolphins are the most common dolphin species and can be found in temperate and tropical waters across the globe, our populations exhibit a feeding behavior that is not found anywhere in the world except for a small stretch of the U.S. Atlantic coast.

This technique is called strand feeding and involves a pod of dolphins chasing a school of fish onto a bank, such as beach or muddy shore. Then, with a massive burst of energy, they take turns heaving their bodies onto land to catch the stranded fish. This unique type of hunting raises the question of how these behaviors are passed on between generations: are they taught or inherited?

It's an amazing display of synchronicity and timing. It's claimed to primarily happen only here in the Lowcountry and around coastal Georgia. However, it has been reported in a few other places around the world as well. If you ever see this in our area, consider yourself lucky!

Strand feeding is a sight to behold.

ALLIGATORS

A reptile with prehistoric lineage, the alligator has a very distinctive appearance with its armored lizard-like body and a long muscular tail and powerful jaws. Hundreds of alligators make their home in the lagoons and ponds on Fripp Island. While fascinating creatures, alligators are dangerous and it is illegal to feed them. They also can be found on the beach in standing water or tidal pools.



While visiting Fripp Island, please keep away from all lagoons, ponds and standing water (tidal pools) especially on our beach. There is no fishing, crabbing, swimming or wading in these waters. Just because you cannot see an alligator, it does not mean that one is not there.

For your own safety, please keep yourself, children and pets away from our lagoons, and pay extra attention to alligator presence on the beach.

DO NOT FEED THE ALLIGATORS.

Feeding or harassing alligators is dangerous and illegal. Once fed, the alligator connects humans with food and loses its fear of them.

DEER

A large herd of whitetail deer live on Fripp Island. Island deer tend to stand smaller than those found further North. Their coats change with the seasons. In winter, coats are darker so the sun's heat is absorbed. In the Spring, that coat is shed for one lighter in color to reflect that light. Dusk is the best time to see deer. Look, **BUT DO NOT FEED OR TOUCH THEM.** While they may seem domesticated, the deer are wild and must be treated with respect.

BIRDS

Fripp Island is a bird sanctuary abounding with shorebirds, songbirds, and marsh birds, and is one of the largest undisturbed marsh and coastal areas on the Atlantic Coast. Over 80 species of birds can be seen on Fripp.

In 2010, the National Audubon Society identified Fripp as part of an "Important Bird Area." Soaring bald eagles and ospreys, painted buntings that appear in the spring, migrating shore birds, brown pelicans and wood storks which both were once endangered, as well as numerous egrets and blue herons, are among the many birds to be seen on Fripp Island.

FISH

The waters around Fripp Island have long been known as a fisherman's paradise.



In addition to crabs and shrimp, fishermen catch all kinds of fish, from trout and blacktip shark to Spanish mackerel, sheepshead, and flounder.

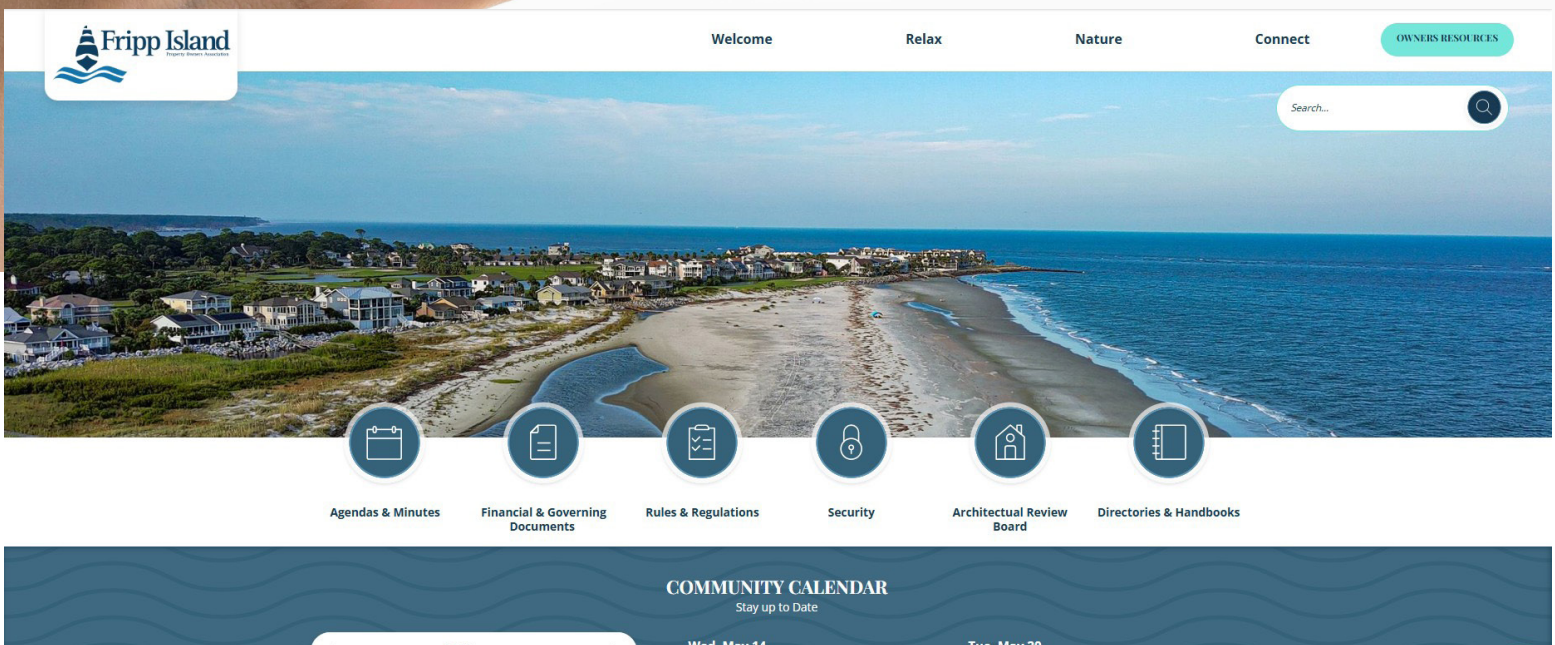
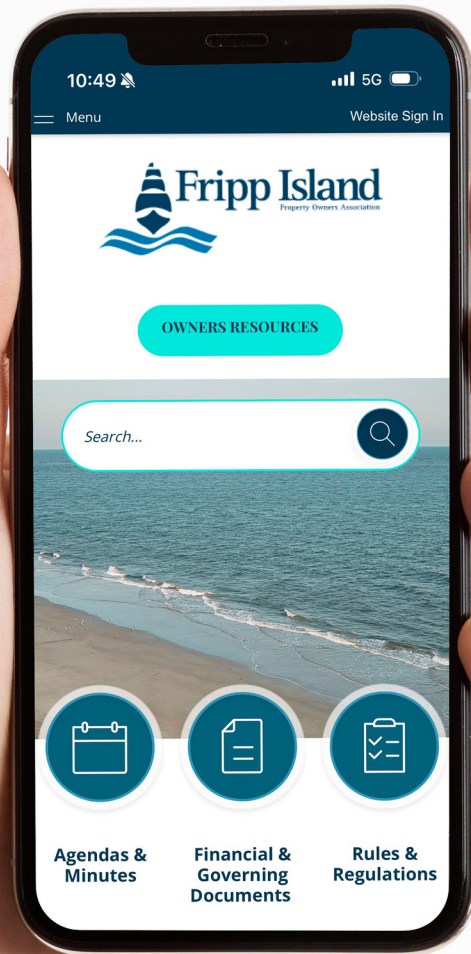
